SECTION 4: First aid measures

4.1. Description of first aid measures

Eye contact: Immediately flush eyes with water, holding eyelids apart, for at least 10 minutes. Seek medical assistance if irritation persists.

Skin contact: Remove contaminated clothing, wash skin with water and seek medical attention if irritation persists.

Inhalation: In case of overexposure, remove to fresh air, keep warm and at rest, seek medical assistance immediately.

Ingestion: Do not induce vomiting. If conscious, give water to drink. Seek medical assistance immediately.

Shelf life: 24 months in original sealed containers.

7.1. Precautions for safe handling

Do not mix with other products. Observe good industrial hygiene.

7.2. Conditions for safe storage, including any incompatibilities

Store in a cool, dry place protected from frost and away from acids, strong oxidising agents and sources of ignition. Store upright in original containers. Recommended storage temperature 5-25°C.

7.3. Product Uses

This product may be used neat in winter to resist freezing (approximate freezing point -4 °C). Under conditions of light frost the fluid may be used diluted with an equal volume of water. May be used diluted 1 part with 3 parts of water in the summer, when the solvent content will assist in removing insect and traffic film deposits.

Please refer to product safety data sheet before use. Use only as directed.
